Sub: IHRD – Engineering College – Assistant Professors who had not acquired Ph.D within stipulated time – Reverting to previous post – reg

- Ref: 1. This Office Proceedings of even no. dated 19.7.2007 and 30.7.2007
  - Minutes of 91<sup>st</sup> meeting of Executive Committee of IHRD dated 26.8.2014

As per G.O. (P) No. 122 /2004/H.Edn dated 18.9.2004, the prescribed qualification for the post of Assistant Professor is Ph.D. As per proceedings read (1) dated 19.7.2007, 46 incumbents were appointed to the promotion post of Assistant Professor of Engineering Colleges. As per proceedings read (1) dated 30.7.2007, it was ordered that the above Assistant Professors are appointed on condition that they are exempted from possessing Ph.D degree but they will have to acquire Ph. D degree before 18.7.2014, the mandatory qualification for the post.

As per the report furnished by respective Head of Institutions, 23 Assistant Professors (now re - designated as Associate Professor as per G.O. (P) 389/10/H.Edn dated 7.12.2010) have not acquired Ph.D before 18.7.2014. The matter was placed before the 91<sup>st</sup> meeting of Executive Committee of IHRD. The Committee resolved to initiate necessary action as per rules in respect of Assistant Professors who have not acquired Ph.D degree before 18.7.2014. As per rule, if an employee does not possess the qualification prescribed for a post, the employee should be reverted back to the previous post. Hence the following Associate Professors who had not acquired Ph.D degree within the stipulated time provided by IHRD and who do not possess qualification prescribed by AICTE and Government are to be reverted back to the previous post mentioned against their name from which they were promoted and appointed to the post of Assistant Professor during 2007.
