IHRD – Engineering Colleges – Reversion of Assistant Professors (pre – revised) who have not acquired Ph.D within 7 years of appointment – orders issued.

ORDER

Twenty three Assistant Professors under IHRD who were appointed during 2007 with direction to acquire Ph.D within 7 years and who have not acquired the prescribed qualification within 7 years were reverted back to their previous posts vide paper read (1). The qualification prescribed for the post of Assistant Professor (pre-revised) as per paper read (2) is Ph.D degree with 1st class degree at Bachelor's or Master's level in the appropriate branch of Engineering / Technology & 3 years experience in teaching / Industry/ Research at the level of lecturer or equivalent.

The Hon'ble Kerala High Court vide paper read (3) has directed this office to hear the Assistant Professors in person and issue final orders. As per the direction of the Hon'ble High Court, hearing of Assistant Professors were done by this office on 24.11.2014 and 23.12.2014. Twenty Assistant Professors have appeared for the hearing and three have requested extension of date which was declined as it will exceed the time limit allowed by Hon'ble High Court. All the twenty Assistant Professors have requested more time to acquire Ph.D which is not admissible.

The Hon'ble High Court of Kerala has stipulated that appointments in Engineering College shall be made strictly in accordance with qualifications prescribed by the AICTE. The 19th Governing Body of IHRD held on 07.02.2011 has resolved that AICTE/ UGC norms in force from time to time is applicable to the faculty members working in Engineering Colleges on the same terms and conditions.

The Government complying to Hon'ble High Court judgement have cancelled the promotion to the post of Assistant Professor (pre- revised) under DTE due to lack of possession of Ph.D within stipulated time of 7 years. IHRD being a Government owned institution is bound to adhere to the stipulations laid down by Government from time to time. Hence the following Assistant Professors who were appointed from the posts mentioned against their name are reverted back to their previous posts and posted to the institutions with immediate effect as shown below.
