ORDER

During the local audit of accounts of IHRD for the period 2014-2015, it was observed that, the Regional Centre of IHRD Ernakulam has no activity during the period 2011-2012 to 2014-2015 but at the same time Rs. 1.24 crores was incurred towards pay and allowances to the idling staff. Similarly the strength of students for the short term, long term and academic project work etc.. of the Regional Centre, Thiruvananthapuram showing a decreasing trend during 2011 to 2014 and these necessitated redeployment of excess staff working in these institutions as per the revised staff pattern implemented as per the reference read as first paper above. The services of staff idling in the above two institutions can be effectively utilized in those associate institutions facing acute shortage of regular faculties for its smooth functioning. The above position has been examined in detail and accordingly the following transfer and postings are ordered with immediate effect.
