IHRD - Extending the benefits of 9^{th} Pay Revision to nine categories of posts as per the Staff Pattern approved by Government - Sanction accorded - Orders issued.

ORDER

In this office Proceedings read as third paper above, the orders on revision of scale of pay and allied matters for State Government employees issued as per G.O.(P) No.85/2011/Fin dated 20-2-2011 has been extended to the IHRD employees w.e.f. 1-7-2009 as ordered in the G.O. read second paper above subject to certain terms and conditions mentioned therein. At the time of implementation of 9th Pay Revision, nine categories of posts being occupied by the regular hands have been excluded in the Pay Revision order stating that, their posts are not included in the Staff Pattern approved by Government. Government in the reference read as 4th paper above included the nine categories of posts in the Staff Pattern and also accorded sanction to extend the benefits of 9th Pay Revision to these posts being occupied by the regular hands vide G.O. 5th cited. In the above circumstances, the following orders are issued.

- (1) Sanction is accorded for the extension of 9th Pay Revision benefits to nine categories of posts as per the G.O.(MS) No.165/2018/HEDN dated 14-7-2018 to IHRD employees on the same terms and conditions as ordered in this office Proceedings read as third paper above subject to ratification by the Executive Committee of IHRD. Copy of the Government Order is attached.
- (2) The Heads of institutions shall ensure that, the fixation of pay and arrears of pay in the revised scale for the period from 1-7-2009 to 31-12-2014 shall be notional and monetary benefits only from 1-1-2015 onwards.

(3) In case of any doubt regarding pay scales, fixation etc., clarification should be obtained from this office before taking a decision.
