IHRD – Bifurcation of different streams – Option exercised by the faculty members for bifurcation of streams for CAS/MPTC/THSS under IHRD – Sanction accorded - Orders issued

ORDER

The revised Staff Pattern of IHRD (Headquarters) and all associate institutions, the revised Special Rules for all categories of posts and subsequent amendments approved by Government in the reference read as first to fifth above have been extended to IHRD employees from 14.02.2014 and 09.12.2014 respectively with the concurrence of the 21st meeting of the Governing Body of IHRD held on 09.12.2014. As per the Special Rules of IHRD approved by Government, there are different streams for faculty members as Engineering College Stream B, College of Applied Science Stream C, Model Polytechnic College Stream D and Technical Higher Secondary School Stream E. As far as Stream B Engineering Colleges are concerned, it was already bifurcated before 01.06.1999 to fulfill AICTE/UGC requirement and also ordered that the teaching faculty members under AICTE/UGC should not be transferred to teaching posts under state pattern and vice-versa. Hence, it is essential to bifurcate the remaining of the streams to suit the academic requirement in accordance with the Special Rules of IHRD. The entire matter has been placed before

the Executive Committee for suitable decision. The 103rd meeting of the Executive Committee of IHRD held on 30.06.2021 accorded permissive sanction to bifurcate the CAS, MPTC & THSS Stream after inviting option from faculty members against the sanctioned post as per the Staff Pattern and without any additional commitment to IHRD. As per the resolution of the Executive Committee options were invited from all faculty members working in non- Engineering Colleges and System Analyst working in the Engineering Colleges and IHRD (Headquarters) as per this office Circular dated 30.09.2021 on condition that, those who have not opted any of the stream, such faculty shall be posted according to the requirement of the institution/subject to the availability of vacancy.

Accordingly, options have been received from all faculty members except Smt. Nimmy Prakash, System Analyst, (now on unauthorized absence) Model Polytechnic College, Mala. As per this office proceedings read 9th paper, a Sub-committee has been constituted by the Executive Committee to scrutinize the options received from faculty members. The Sub- Committee constituted by the Executive Committee which met on 15.02.2022 scrutinized the options received from faculty members for bifurcation of streams for CAS/MPTC/THSS under IHRD with reference to the Staff Pattern and Special Rules approved by Government. After detailed discussion, considering the workload of faculty members and the closure of certain branches in the educational institutions, new policies of University and financial position recommended to bifurcate the faculty members as per their option into various streams such as College of Applied Science, Model Polytechnic College and Technical Higher Secondary School. The committee also observed that, the option to Engineering College service from the faculty members cannot be considered since the Engineering College service have already been bifurcated by inviting option and brought within the purview of AICTE/UGC. But, certain posts of System Analyst on Rs.39500-83000/-in the state scale of pay as per the Government approved Staff Pattern are available in the Engineering Colleges which are equivalent to the post of Lecturer (Computer) in College of Applied Science and Lecturer in Computer Application in Model Polytechnic Colleges and the posts are interchangeable. Considering the above, System Analysts who are now working in Engineering Colleges are to be placed in any of the streams C, D & E in order and subject to availability of post/workload as per University norms in force. Moreover as per G.O (Ms) No.76/2014/HEDN dated 14.02.2014, Government ordered that only 60% of posts could be filled up with regular staff in all institutions.

In the above circumstances, sanction is accorded for the bifurcation of faculty members in different streams other than Engineering Colleges on condition that, the teaching faculty members under CAS stream should not be transferred to MPTC stream and THSS stream and vice versa. The name of faculty, stream and institution to which they have been posted after bifurcation is noted against their names.
