
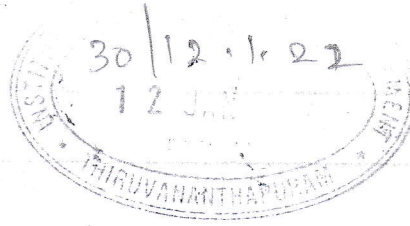

GUIDELINES

1. OBJECTIVE:

In its efforts to promote excellence in various areas of New and Renewable Energy technologies in the State, Government of Kerala has constituted the "Kerala State Renewable Energy Awards" from 2017 onwards. The Award is given in recognition to the selected enterprises, organizations and individuals who have made systematic and serious attempts for efficient utilization of Renewable Energy Technologies, its Research & Promotion etc. The qualifying period for the Renewable Energy Awards for this particular year would be 2019-20 & 2020-21.

Accordingly, the Renewable Energy Award - 2021 would consider activities undertaken in the State of Kerala, from 1st April 2019 to 31st March 2021.

2. THE AWARDS:

The awards are proposed to be given in the form of a Plaque with appropriate citation on such award, as may be decided by the State Level Monitoring Committee for Renewable Energy Awards in Kerala.

- 2.1 The candidates shall submit the applications (by mail and by post) with all details in the prescribed format before the last date announced. Late applications will not be entertained. The Award judging committee will evaluate the applications received on the basis of the details submitted, interview of the applicant and a site visit if necessary.
- 2.2 The judges reserve the right to move an entry in a particular category to any another category which the committee finds suitable, on the basis of the area of activity of that institution/individual as per the profile submitted.
- 2.3 In case of more than one winner in any category, the Cash prize will be shared equally
- 2.4 Individuals applying in the category of "Research and Innovation" may submit the details of Tests, Testimonials, and Certifications authenticating their work/ from an approved/Accredited Institution/Lab as applicable. In the absence of the same, the Judges, if not otherwise able to get convinced about their contribution in Renewable energy sector, reserve the right to reject such applications.
- 2.5 If suitable applicants are not identified in any category, the award in that category will not be announced.
- 2.6 Those enterprises / organizations / individuals, who have received Awards within the last three years are not eligible to apply in that category.
- 2.7 Only Individuals / Institutions / Organisations who are having their area of functioning in Kerala are eligible to apply for awards

3. ELIGIBILITY/CATEGORISATION

The scheme is open to all enterprises in the State of Kerala, as per the categorization listed below.

Category	Eligibility
I. Award for Outstanding Contribution in Renewable Energy (Individuals and Public Institutions) – on nomination basis	An eminent Personality or a reputed Public Institution nominated by a prominent individual/organisation for their outstanding contribution in Renewable Energy in the State of Kerala.
II. Public Sector Enterprises	This category includes public sector companies owned by State or Central government or its subsidiaries which are functioning in the state of Kerala. Industries working in cooperative sector or in public- private partnership mode and functioning in the state of Kerala are also eligible to apply.
III. Education Sector	Educational Institutions, which have implemented Renewable Energy projects/involved in Research and Development activities of Renewable Energy Technologies in the State of Kerala.
IV. Local Self Governments	Administrative Bodies of local Self Governments in Corporations, Municipalities, District Panchayats, Block Panchayats and Grama Panchayats which have implemented Renewable Energy projects/involved in promotional efforts in the State of Kerala.
V. Commercial Sector	Commercial Buildings – new & retrofits – including hotels, hospitals, shopping malls etc. which have implemented Renewable Energy projects in the State of Kerala
VI. Transportation Sector	Firms which have contributed to the society by switching to Electric or any other alternate sources of energy for transportation purposes or who have made substantial contribution

VII. MSME Sector - Renewable Energy Usage	Micro, Small & Medium Enterprises, having MSME certificate from the industries department and have implemented Renewable Energy projects or involved in any kind of promotional, Research and Development activities in Renewable Energy Technologies in the State of Kerala
VIII. Non-profit Organisations	Non-Profit Organisations involved in promotional efforts/Research & Innovation in renewable energy technologies in the State of Kerala
IX. Research & Innovation (Individuals & Institutions)	Individuals/Public Institutions who have carried out Research & Innovation in Renewable Energy Technologies and have successfully implemented such projects in the State of Kerala
X. Young Entrepreneur	Entrepreneurs below the age of 37 who have initiated business (trade or manufacturing) connected with Renewable Energy products.
XI. RE Power Industries (Large Industries including IPPs, Captive consumers etc)	Large industries (other than MSMEs) having their production units in the state of Kerala including Independent Power Producers / Captive Power Consumers which have carried out notable Renewable Energy installations in the State of Kerala.
XII. RE Industries (Manufacturers, Integrators etc.)	RE System manufacturers, System integrators which have carried out notable Renewable Energy installations in the State of Kerala.
XIII. Skill Development in Renewable Energy	Training centres, Educational Institutions, NGOs, Research and Development Organisations engaged in skill development or training in Renewable Energy related subjects can apply under this category.

4. CRITERIA FOR JUDGING THE MERIT

4.1 The Committee will decide the recipient of the awards on the basis of outstanding achievements and contribution in the field of Renewable Energy. The Award may not necessarily be decided on the basis of only quantitative achievements but also taking

into account the various other factors such as Innovative techniques and Technologies adopted, commitment of the Management, Environment Friendliness, Sustainability potential of the organizational set-up, contribution made in promotion of the message of Renewable Energy in the Society etc.

- 4.2 The members of the Award Committee or their nominees may visit participating enterprises/organizations/individuals for verification of data submitted, if felt necessary, and it will be obligatory on the part of the participating units to provide necessary assistance and co-operation for such visits.
- 4.3 On the basis of the scrutiny of the applications and site visit the Committee will prepare a short list of the applicants in each category. The shorted listed candidates will be invited for a presentation before the Committee. The candidate shall bear all the expenditure in connection with his travel and preparation for the presentation if any.
- 4.4 The Aspects that could be considered while judging the application includes but not limited to the following factors:
- a. Total installed capacity of the implemented Renewable project
 - b. Research and Development component involved
 - c. Usage of Innovative technologies
 - d. Technical and environmental risk
 - e. Cost of energy saved through energy generation using RE resources
 - f. Sustainability

The Committee's decision would be final and no appeal for re-consideration shall be entertained.

5. SUBMISSION OF NOMINATION

Application forms can be downloaded from the ANERT website - www.anert.in.
