The scheme for deputation of regular faculty members of Engineering Colleges under IHRD for Ph.D/M.Tech Programme was revised and orders issued vide this office proceedings read 1st above. In this office proceedings dated 29.06.2015, modified orders were issued restricting the benefits of pay and allowances to basic pay plus academic grade pay to the deputationists under the scheme. Further, the deputations for M.Tech programme was cancelled and the no. of seats for Ph.D programme on deputation were enhanced from the academic year 2021-22 onwards and revised conditions were introduced for the completion of Ph.D programme vide this office proceeding dated 06.01.2020. In this backdrop, applications are invited for deputation of faculty members of IHRD for Ph.D programme for the academic year 2023-'24 as shown below.

The applicants for inclusion in the panel for deputation for Ph.D studies should have completed two years regular service under IHRD. The selection of faculty members for the above programme will be done by a Screening Committee. The terms and conditions for deputation and selection shall be as mentioned in this office proceedings read (1) & (2) above. No deviation on the terms and conditions already fixed is possible. The regular faculty members who have completed two years regular service as on 01.07.2022 alone are eligible to apply under the scheme. Applications of the employees who have not completed two years regular service under IHRD as on 01.07.2022 need not be forwarded to this office.

The maximum age limit for deputation of faculty members for higher studies is 45 years as on 01.07.2022.

The last date prescribed for the receipt of application in the prescribed format by the heads of the Engineering College is fixed as 17.11.2022. The applications so received by the Principals of Engineering Colleges shall be

forwarded to this office duly verified and recommended so as to reach here on or before 19.11.2022. Late applications will not be considered under any circumstances.

The heads of institutions will circulate this communication among the regular faculty members working under them as well as the employees proceeded on deputation obtaining dated acknowledgement.

This notification is issued subject to disposal of WP(C) No.19627 of 2015 pending before the Hon'ble High Court of Kerala.
