ORDER

Admit.

Standing Counsel for Kerala State Electricity Regulatory Commission takes notice for the 1st respondent.

Standing Counsel for the KSEB takes notice for the 2nd respondent.

There will be an interim direction to the 2nd respondent not to issue further demand notice for the arrears under categorized LT-VI(F) General for two months, but the respondents are free to demand the amount as per LT-VI(A), subject to the result of the writ petition.

The interim order is passed, after going through Ext.P3 Government Order.

I make it clear that the interim order will be subject to the result of the writ.

petition, and the respondents are free to file counter affidavit and file urgent memo, to vacate the interim order, if they are aggrieved by this order.
