I am happy to inform you that IHRD is planning to initiate an attractive Closed User Group (CUG) scheme of BSNL mobile connections for all interested IHRD staff members. Those who join this scheme of post paid connection can enjoy unlimited free calls (local) within the group and 500mts of free calls per month outside the group. Existing BSNL prepaid mobile users can migrate and postpaid mobile user can be added to this group. Others who join this group have to take a new mobile connection. A copy of detailed tariff of this plan is enclosed herewith and is also available in the IHRD web site.

The head of all institutions under IHRD are requested to inform about this scheme and tariff to all staff members and to e-mail the list of existing BSNL users who wish to join this scheme, with the following details, to IHRD Headquarters on or before 12th November, 2010.

- a) Name of the staff
- b) Designation
- c) Existing BSNL mobile number
- d) Type of connection (Prepaid/postpaid)
- e) Address to which postpaid bills are to be sent

Those who need a new BSNL connection under this scheme are directed to download and fill up the prescribed performa for the same from the IHRD website and forward it to IHRD Headquarters through the concerned head of institution on or before 19th November, 2010

Mobile CUG Scheme of BSNL for IHRD Staff

IHRD is planning to initiate an attractive Closed User Group (CUG) scheme of BSNL Mobile connections for all interested IHRD staff members. The main features of this package are as follows

- a) Activation charges, service tax,
Deposit charges and CUG charges - Nil
- b) Calls within CUG - Unlimited Free
- c) Free calls/month - 500 Mts (*300 Mts to BSNL local mobiles and 200 Mts to all other local mobiles and landlines*)
- d) Free sms/month - 350 local /national
- e) Reduced call charge facility to 2 BSNL numbers within Kerala - 20 paisa/minute
- f) Pulse rate - 60 seconds
- g) Local charges
 - 1) *to all mobiles* - 0.30
 - 2) *to BSNL landlines* - 0.40
 - 3) *to other landlines* - 0.49
- h) STD charges to all mobiles and landlines - 0.49
- i) SMS
 - 1) Local and national - 0.30
 - 2) International - 5.00
- j) ISD
 - 1) *USA, Canada, U.K* - 7.20
 - 2) *Bangladesh, Bhutan, Maldives, Pakistan, Nepal* - 9.00
 - 3) *Europe, Singapore, Thailand, Malaysia, Indonesia, Hong Kong, Kuwait, Bahrain, UAE* - 9.60
 - 4) *Rest of the world* - 12.00
- k) Roaming (*local & std*) - 1.00
- l) Monthly fixed charges - 149.00
- m) Service tax @ 10.3% extra
