ORDER

The Executive Committee of IHRD held on 17.04.2007 had resolved to implement the State Government Orders on the implementation of UGC Pay Packages Scheme for the Arts and Science faculties in the Engineering Colleges under IHRD with effect from 01.07.2006 by the reference read as first paper above. By the proceedings read third paper above, orders were issued for implementing the UGC Scheme for Arts and Science under IHRD as per the guidelines issued by the Government Order read second paper above with effect from 01.07.2006 FN.

- The Hon'ble High Court of Kerala had disposed the W.P (C) No.25276/07, W.P (C) No.18048/07, W.P (C) No.28370/07 etc.... directed the IHRD to invite fresh options for Engineering College Service and to consider the case of petitioners subject to their academic qualifications and other requirements. Accordingly, notification were issued for option from all head of institutions faculties. Based on the option submitted by the head of institutions faculties provisional and final seniority lists has been published.
- In the above circumstances, the undermentioned head of institutions faculty members working in the associate institutions are sanctioned UGC Pay Package as per the guidelines issued by the Government Order read as second paper above in the scale of pay of Rs.8000-13,500/- notionally with effect from 01.01.1996 and monetary benefit only from the date of joining duty.

- 4) The Head of Institutions are directed to relieve the faculty members with direction to report for duty to the posted institutions forthwith.
- As far as the head of institutions (Principals of CAS/THSS) are concerned, the IHRD is facing shortage of senior faculties for assigning the additional charge in certain associate institutions. Taking into account of the above position, all head of institutions (CAS/THSS) posted to Engineering College under UGC Scheme stands relieved from the respective institutions forthwith with direction to report for duty to the newly posted institution after assigning current duty to a seniority faculty. However, all head of institutions who are transferred out on UGC option are posted to their existing institutions on working arrangement basis for a period of 3 months or till a substitute assume charge whichever is earlier.
- The salary in the post under UGC will be paid from the institution to which they are posted on UGC option on receipt of attendance certificate from the respective institutions in which they are posted on working arrangement basis.

- 7) The Principals of Engineering Colleges concerned will fix the pay of the above faculties in accordance with the provision in the Government Order read as second paper above.
- 8) The date of relief/joining duty of the incumbent shall be reported to this office in due courses.
