CIRCULAR

Sub:- *IHRD – Availing of Security Service from Kerala State Ex-Serviceman Development and Rehabilitation Corporation (KEXCON)-(A Government of Kerala undertaking) – instructions issued – Reg:-*

Ref:- *Resolution of the 94th meeting of the Executive Committee of IHRD held on 28.12.2016.*

The Kerala State Ex- Serviceman Development and Rehabilitation Corporation (KEXCON) has been established by the Government of Kerala for the rehabilitation of Ex-Serviceman, Widows and their dependants. As part of its activities KEXCON Sponsors Ex-Serviceman and their dependents as Security personnel to the State and Central Government establishments. The above matter has been placed before the Executive Committee for suitable decision. As resolved by the Executive Committee of IHRD, the following instructions are issued.

1. All heads of institutions are permitted to engage candidates sponsored by M/s Kerala State Ex- Serviceman Development and Rehabilitation Corporation (KEXCON) also as Security Guard similar to that of Zila Sainik Welfare Board (ZSWB) in IHRD institutions in pursuance of Government Circular No. 71307/12/GAD dated 01.10.2012 (copy attached for reference).
2. As far as possible, the head of institution shall utilize the services of Last Grade Servant (consolidated pay) working in the institution for ward duty to minimize the expenditure.
3. Receipt of the circular may be acknowledged by return.

As per the Government Order 1st cited Government have constituted the Kerala State Ex-servicemen Development and Rehabilitation Corporation (KEXCON) with a view to implement schemes for the welfare and rehabilitation of Ex-Servicemen and their dependents.

As a part of its operation the Corporation has been sponsoring Ex-Servicemen as Security Guards to State and Central Public Sector Undertakings/ Local Bodies/ Quasi Government Organizations and Establishments. In order to support their efforts to sustain in the field of security related services as per the Government Order referred to above, Government have issued instructions to all Heads of Departments, Public Sector Undertakings, Local Bodies and other Quasi Government Organizations and Establishments, directing them to approach KEXCON for Security Personnel sponsored by the Corporation only and not from any other private agencies/Ex-servicemen sponsored by private agencies for any contract job/employment.

The Managing Director, KEXCON as per letter 4th cited have brought to the notice of the Government that despite orders to engage the Ex-Servicemen sponsored by the Corporation for Security related duties, many Public Sector Undertakings, Local Bodies and other Quasi

Government Organizations are not complying with the Government direction contained in the Government Order and circular 1st and 2nd cited.

In the above circumstances All Heads of Departments, Managing Directors/Chief Executives of Public sector Undertakings and Head of the Institutions of Local Bodies and other Quasi Government Organizations once again directed to engage Security Personnel from KEXCON for security related duties and not to invite Tender/quotation from private agencies for the purpose. It is also instructed to terminate the existing contract with private agencies and enter into contract with KEXCON.


The Officers concerned will be personally held responsible for any lapse to comply with the Government Order.
