**ORDER**

Due to acute financial crisis being faced by IHRD, there was a shortfall in the remittance of CPF Subscription /Contribution and Gratuity contribution to the IHRD employees. In this regard it has come to notice that the employees are facing much difficulty even to avail TA/NRA from their CPF account. The matter having been examined in detail, it is decided to allot fund from the available balance in the consolidated account of IHRD. Accordingly, the following orders are issued.

1. Sanction is accorded for the allotment of fund for clearing the pendency of CPF subscription and CPF Loan recovery up to the month of December 2024 of employees under all associate institutions of IHRD.
2. Hence sanction is hereby accorded to release an amount of **Rs.1,62,00,671/- (Rupees One Crore Sixty Two Lakh Six Hundred and Seventy One Only)** to the following institutions for meeting the pending payment under the head of account “CFP Subscription & CPF Loan Recovery” up to the month of December 2024.

3. The head of institutions concerned shall remit the amount to the CPF account maintained by the respective trust ensuring no pending dues and forward the schedule for the amount in respect of the employees on or before 21/01/2025
4. The Institutions with asterik mark (\*) against their name with 'Nil' remarks regarding pending amount of CPF contribution, have already cleared the entire arrears of CPF contribution. However, the Heads of those institutions are observed to have openly violated the instructions from the Head Quarters issued as a part of financial management, to disburse only net salary during the previous two months and transfer the remaining amount to Head Quarters to meet the salary/wages requirements of other institutions with deficiency of funds. Their action in having defied the orders of Headquarters is seen as a purposeful attempt to torpedo the financial management of IHRD. Hence they shall furnish explanation for the same within a period of one week.
5. The head of institution should ensure that, the amount shall be utilized only for the purpose for which it was allotted
