Sealed quotations are invited for the supply of materials specified in the schedule attached below/overleaf. The rates quoted should be for delivery of the articles at the place mentioned below the schedule. The necessary superscription, due date for the receipt of quotations, the date up to which the rates will have to remain firm for acceptance and the name and address of the officer to whom the quotation is to be sent are noted above. Any quotation received after the time fixed on the due date is liable to be rejected. The maximum period required for the delivery of the articles should also be mentioned. Quotations not stipulating period of firmness and with the price variation clause and / or 'subjects to prior sale' condition are liable to be rejected.

The acceptance of the quotations will be subject to the following conditions:

1. Acceptance of quotation constitutes a concluded contract. Nevertheless, the successful tenderer must within a fortnight/ a month after the acceptance of his quotation furnish 5 percent of the amount of the contract as security deposit and execute an agreement at his own cost for the satisfactory fulfillment of the contract, if so required.
2. Withdrawal from the quotation after it is accepted or failure to supply within a specified time or according to specifications will entail cancellation of the order and purchase being made at the offerer's expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the Government reserves also the right to remove suppliers permanently or for a specified number of years.
3. Samples, duly listed, should be forwarded if called for under separate cover and the

origin/supply or delivery during the course of execution of the contract.

- 10.(a). Ordinary payments will be made only after the supplies are actually verified and taken to stock but in exceptional cases, payments against satisfactory shipping documents including certificates of insurance will be made upto 90 percent of the value of the materials at the discretion of Government. Bank charges incurred in connection with payments against documents through bank will be to the account of the contractor. The firms will produce stamped pre-receipt invoice in all cases where payments (advance/final) for the release of railway/shipping documents are made through bank. In exceptional cases where stamped receipts of the firms are not received for the payments (in advance) the unstamped receipt of the Bank (ie. Counterfoils of pay-in-slips issued by the bank) alone may be accepted as valid proof for the payments made.
- (b). The tenderers shall quote also the percentage of rebate (discount) offered by them in case the payments is made promptly within fifteen days/ within one month of taking delivery of stores.
11. Any sum of money due and payable to the successful tenderer or contractor from the Government shall be adjusted any sum of money due to Government from him under any other contracts.
12. Special conditions, if any printed on the quotation sheets of the tenderer or attached with the tender will not be applicable to the contract unless they are expressly accepted in writing by the purchases.
