Conditions for appointment as Statutory Auditors

2. Should produce proof of experience.
3. The audit of accounts of IHRD institutions of a financial year should be conducted and the report shall be submitted before 31st July of the succeeding financial year.
4. The report submitted should contain a stream-wise/institution wise review of Receipt and Expenditure indicating Surplus/ Deficit statements in each case indicating measures for improvement.
5. The appointment is for a period of one year extendable up to 3 years maximum.
